**Terms & Conditions governing submission of Rate Proposals are as under:**

**Services:** Supply of Car/Taxi (alongwith Driver) for local and outstation visits (Ex-Jaipur & Ex-Delhi)

**Vehicle Categories:** Deziere/ Toyota Innova (Crysta)/ Maruti Ertiga/Toyota HyCross

**Period of Service:** 1<sup>st</sup> April 2026 to 31<sup>st</sup> March 2027

**Mode of Service:**

- i. Full Day – Local City – (12 hours/ 120 kms)
- ii. Half Day – Local City – (08 hours/ 80 kms)
- iii. Local City (04 hours / 60 kms)
- iv. Airport Transfer – Local City
- iv. Outstation (Inter City/Inter States)

**Other terms and conditions:**

1. Validity of Rates offered will be valid for the period of award of contract (1<sup>st</sup> April 2026 to 31<sup>st</sup> March 2027). No request for increase of rates/ charges for any reason shall be entertained during the period of Contract.
2. Car/Taxi services will be hired on as and when requirement basis for local city and/or outstation travel.
3. Variation in service schedule/vehicle category or class shall be subject to prior approval by RIDCOR
4. Charges towards toll taxes, parking, inter-state taxes shall be paid on actual basis subject to production of original supporting/receipt.
5. No extra-cost towards any penalty, challan, loss/damage to vehicle or loss of life shall be payable by RIDCOR due to negligence of driver, incomplete vehicle papers, vehicle fitness etc.
6. Payment against Invoices shall be made after submission of final invoices. Invoice may include all supporting documents including Duty-slip (duly verified by the user), toll and parking charges etc. All supporting documents as above to be verified by the Agency/Service Provider. Incomplete invoices, in any manner, will not be accepted by RIDCOR.

7. Payment will be subject to deduction of taxes as applicable from time to time.
8. Agency will ensure supply of vehicles in very good condition, fully insured (including Riders coverage) with all necessary documentation.
9. In case of break-down of vehicle / Complaint raised by the user Guest about condition of vehicle/ behavior of driver/ or other justifiable reasons during the use of vehicle, Agency shall ensure supply of alternative same or higher class of vehicle to the Guest withing reasonable time on the same day without any extra charges.
- 10.No additional cost in addition to the rate proposal (as per Annexure-I) shall be entertained from the Agency.
